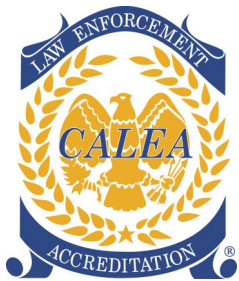

## Payment by gift card? It's a scam!

Gift cards are popular and convenient... and not just for gifts. Criminals have latched onto gift cards as a convenient form of payment in their scams. In a 2022 [AARP survey](#), 1 in 3 adults said they or someone they know had been asked at some point to purchase a gift card to pay a bill, fee or some other debt or obligation or to claim a prize. About one in four adults who were contacted reported they bought the cards,

## Signs to watch for

1. You're directed to buy one or more gift cards — often referred to as “electronic vouchers” — as a quick means of making payment.
2. You're told to share the numbers on the back of the gift cards, by reading them off or sending a picture.
3. The request comes from someone you wouldn't expect to ask for money this way:

A [Social Security](#) warning of a problem with your account

A [utility company](#) warning of an imminent shutoff

A [lottery company](#) promising a big prize — once you pay some fees upfront

A [grandchild needing bail](#) or facing another financial emergency.

## Gift Card Draining



Gift card draining stole \$1B, how to protect yourself now

### **Gift Card Scheme at 2677 Roosevelt, Walmart— From Largo Police Department**

An elderly male purchased several Walmart gift cards for his grandchildren in mid-November. He boxed them up and set them aside until mid-December, when he gave them to his grandkids as Christmas gifts. Each child received a \$20 Walmart gift card.

The kids, excited, attempted to use the cards at Walmart and discovered that there were no funds on them. They notified their grandfather, who took the cards back to Walmart. Walmart staff advised that the cards had already been used and provided transaction dates, times, and locations. All transactions occurred after the original purchase date,

Police were able to obtain kiosk video footage of three of the fraudulent transactions—two in Tampa and one in Georgia. The videos show three different subjects using multiple gift cards during these transactions. These cards are not the ones purchased by the grandfather, but they display the same card numbers. Police believe that the original cards were stolen from Walmart, the packaging was carefully removed, the cards were cloned, and the packaging and original cards were returned to the shelves. The cloned cards were likely sold, and the buyers used them once the legitimate cards were activated and loaded with funds.

## Gift Card Draining

### Spotting tampered cards before you pay

The first line of defense is your own inspection in the aisle. I look closely at the back of every card for mismatched barcodes, scratches, or stickers that look like they have been peeled up and reattached, all of which can signal that someone has already accessed the code. Experts warn shoppers to [avoid cards with mismatched barcodes or loose PIN stickers](#) and instead reach for versions that are fully sealed inside cardboard or plastic packaging, which are harder to tamper with without leaving obvious damage.

Several consumer protection groups echo the same basic checklist. They advise buyers to [check physical gift cards for signs of tampering](#), run a finger over the scratch-off area to feel for bumps or tears, and walk away from any card that looks even slightly altered. The Gift Card Fraud Prevention Alliance goes further, urging people to follow specific [Tips for Keeping Gift Cards Safe](#), including "Check the PIN Cover" and "Inspect the" surface for any sign that someone has already scratched or lifted it. If the packaging is ripped, the PIN is exposed, or the card number looks reprinted, I put it back and choose another.

[Purchase gift cards directly](#) from trusted retailers, either online or in-store, instead of from auction sites, social media marketplaces, or random third party sellers.

Cybersecurity experts urge buyers to [examine the gift card and packaging](#) again right after purchase, confirm that the PIN is still covered, and register the card on the retailer's official site if that option exists.

### What to do if your balance vanishes

If money is already gone, speed is critical. I immediately call the card issuer using the number on the back of the card or on its official website, explain that the card has been drained without authorization, and ask whether they can freeze the remaining balance or issue a replacement. Then I report the incident to the Federal Trade Commission through its dedicated portal at [ReportFraud.ftc.gov](#), which helps investigators track patterns and, in some cases, build cases against the criminal networks behind these schemes.

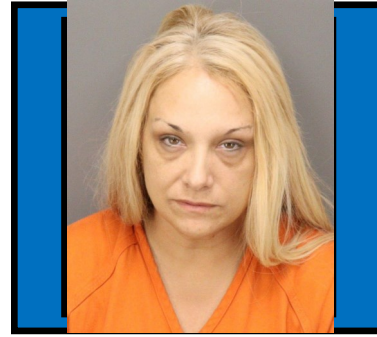

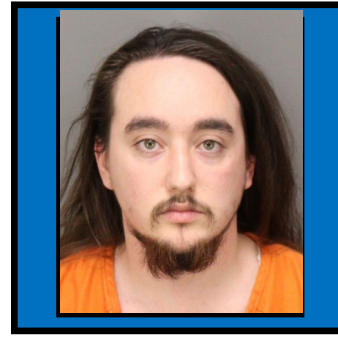
